Application Rules and Deadlines:

- 1) Pageant is limited to the first 12 applicants.*
- 2) Completed applications must be turned into the Coweta Chamber of Commerce by September 2nd by 5pm.*
- 3) Emailed applications will NOT be accepted.*
- 4) Applications will not be considered complete until \$10.00 entry fee is paid.*
- 5) Each contestant must turn in a color no larger than 4x6 headshot this must be received along with the application. Please put the contestants name on the back of the photograph. (This does not have to be a professional picture)
If the photograph is not received with the application a point deduction per day, it is late will be received in the photogenic category.*
- 6) No changes can be made to their talent (types, song changes, etc.) after applications are received. A point deduction in the talent will be received each time they are changed, and judges will be notified.*

RULES AND REGULATIONS LITTLE MISS FALL FESTIVAL PAGEANT

EACH CONTESTANT MUST:

1. Be a female resident of Coweta or enrolled in Coweta Public Schools ages 5-8
2. Be at least five years of age on/or before September 1st. 2026, but not over eight years of age on pageant day.
3. Not be a previous winner of the Little Miss Fall Festival Pageant.
4. Provide her own transportation to and from activities.
5. Be able to attend all activities preceding the Pageant.
6. **Make every effort to attend all activities sponsored by the Chamber of Commerce. A minimum participation of 50% is required. Attendance will be checked quarterly and if attendance is below the required 50%, she will be asked to give up her title and any unused prizes. The first runner-up will be asked to assume the title for the remaining activities and must also conform to the attendance requirements.**
7. Must not have engaged in any activity, which, by community standards, could be characterized as dishonest, immoral, immodest, indecent, or in bad taste.
8. Any monies won will be paid out after pageant reign.

I have read and understand the rules and regulations cited above. Should I agree to submit my resignation as Little Miss Fall Festival or become unwilling or unable to comply with the above rules and regulations, I will return any unused prizes and will hold the pageant and committee and its members harmless from any liability, which may arise, from failure to comply with these rules and regulations.

Requirements:

- ⊗ All participants must be five by September 1st, 2026, to eight years of age on date of pageant.
- ⊗ All participants must be a resident of Coweta or be enrolled in Coweta Public Schools.
- ⊗ No participant can be a previous Little Miss Fall Festival Pageant winner.
- ⊗ A headshot or close-up photograph must be provided with the completed application, if it is not turned in with the application a point deduction in the Photogenic Category will be received. 1 point per day it is late will be received. **PARENT INITIALS**_____.
- ⊗ Talent including the type and name of the song must be completed on the completed application. Any changes to the talent after the applications are turned in will result in a point deduction in the talent category. **PARENT INITIALS**_____.
- ⊗ ***Talent Music must on a Flash Drive in MP3 format and turned in by Wednesday, September 2nd, by 5pm. Any music not turned by the deadline will be omitted from the talent competition and the contestant will perform talent without music. PARENT INITIALS***_____.
- ⊗ **Judges will be notified of any point deductions due to missed deadlines.**
- ⊗ Talent can be no longer than 90 seconds.
- ⊗ The entry forms must be turned in to the Coweta Chamber.
- ⊗ No late entries will be allowed.
- ⊗ No entries will be taken via the telephone.
- ⊗ No live animals, fire hazards, or any other props deemed hazardous may be used for talent (i.e. bow and arrow).
- ⊗ The winner of the 2026 Little Miss Fall Festival Pageant must attend all Coweta Chamber of Commerce sponsored activities, per the Chamber Director. Agree to wear dressy casual attire (no shorts or off the shoulder tops) when representing the Coweta Chamber of Commerce. A minimum of 50% participation is required or the winner must give up her title and the first runner-up will assume the Little Miss Fall Festival duties.
