Application Rules and Deadlines:

- 1) The Pageant is limited to the first 12 applicants.*
- 2) Completed applications must be turned in to the Coweta Chamber of Commerce by
September 2nd 2026, by 5pm.*
- 3) Emailed applications will NOT be accepted.*
- 4) Applications will not be considered complete until a \$10.00 entry fee is paid.*
- 5) Each contestant must turn in a color no larger than 4x6 headshot. This must be
turned in with the application. Please put the contestants' names on the back of
the photograph. (This does not have to be a professional picture)*
- 6) If the photograph is not received with the application a point per day the
photograph is late will be deducted from the photogenic score.*
- 7) No changes can be made to their talent (types, song changes, etc.) after applications
are submitted.*
- 8) If changes are made to Talent after applications are submitted a point per change
will be to the talent score.*

RULES & REGULATIONS
MISS FALL FESTIVAL SCHOLARSHIP PAGEANT

EACH CONTESTANT MUST:

1. Be a female resident of Coweta or attend Coweta Public Schools and between the of ages 13 - 18 (must not have graduated high school).
2. Be at least 13 years of age and/or before the date of the pageant, but not over 18 years of age.
3. Be single & never have been married. If contestant gets married after entering the pageant or during her reign, she must withdraw as a contestant or voluntarily forfeit her title, crown, sash, and all unused awards & scholarships. The First Runner-up will be asked to assume the title for the remaining reign & must also conform to these rules.
4. A current headshot or close-up photograph must be submitted with the completed application. If it is not received, a point deduction of one point per day the overall is not received will be deducted from the photogenic score. *Parent Initials*_____ *Contestant Initials*_____
5. No changes to the Talent type and/or song are allowed once applications have been submitted. Each change made will result in a point deduction for each change made after the application deadline. *Parent Initials*_____ *Contestant Initials*_____
6. *Talent Music must on a Flash Drive in MP3 format and turned in by Wednesday, September 2, 2026 at 5pm. Any music not turned by the deadline will be omitted from the talent competition and the contestant will perform talent without music. NO EXCEPTIONS PARENT INTIALS*_____ *Contestants Initials* _____.
7. Judges will be notified of any point deductions due to missed deadlines.
8. No live animals, fire hazards, or any other props deemed hazardous may be used for talent (i.e. bow and arrow).
9. Judges will be notified of any missed deadlines and of how many points to lower each score by.
10. She must have no children & must not be pregnant. If contestant becomes pregnant after entering the pageant or during her reign, she must withdraw as a contestant or voluntarily forfeit her title, crown, sash, and all unused awards & scholarships. The First Runner-up will be asked to assume the title for the remaining reign & must also conform to these rules.
11. Not be a previous winner of the title of Miss Fall Festival.
12. Provide her own transportation to and from all activities and events.
13. Have at least a 2.75 overall grade point average. *Applications will not be accepted without signature of verifying attached documentation (i.e. PowerSchool print off)*
14. Have no criminal convictions against her.
15. Not have engaged in any activity which, by community standards, could be characterized dishonest, immoral, immodest, indecent, or in bad taste. This does include social media postings on main or "spam" accounts. You are an example to your peers from the day you take your crown to the day you take it off, please act accordingly.
16. *Make every effort to attend all activities sponsored by the Coweta Chamber of Commerce A minimum participation of 50% is required. Attendance will be checked quarterly and if attendance is below 75%, she will be asked to voluntarily forfeit her title, crown, sash, and all unused awards & scholarships. 48hrs required notice The First Runner-up will be asked to assume the title for the remaining reign & must also conform to the attendance requirements.*
17. Agree to wear dressy casual attire when representing the Coweta Chamber of Commerce. Jeans with holes or rips are not appropriate, spaghetti straps and crop tops are prohibited and dresses/skirts must be an appropriate length.
18. Any scholarship monies won will be paid out after pageant reign. And the winner with until December 31 of their graduation year to collect scholarship funds.
